413 HARASSMENT AND VIOLENCE

I. PURPOSE

The purpose of this policy is to maintain a learning and working environment that is free from harassment and violence on the basis of race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability.

II. GENERAL STATEMENT OF POLICY

- a. The policy of Main Street School of Performing Arts is to maintain a learning and working environment that is free from harassment and violence on the basis of race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability. The school district prohibits any form of harassment or violence on the basis of race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability.
- b. A violation of this policy occurs when any pupil, teacher, administrator, or other school personnel of MSSPA harasses a pupil, teacher, administrator, or other school personnel or group of pupils, teachers, administrators, or other school personnel through conduct or communication based on a person's race, color, creed, religion, national origin, sex, age, marital status, familial status with regard to public assistance, sexual orientation, or disability, as defined by this policy. (For purposes of this policy, school personnel includes school board members, school employees, agents, volunteers, contractors, or persons subject to the supervision and control of MSSPA.)
- c. A violation of this policy occurs when any pupil, teacher, administrator, or other school personnel of the school district inflicts, threatens to inflict, or attempts to inflict violence upon any pupil, teacher, administrator, or other school personnel or group of pupils, teachers, administrators, or other school personnel based on a person's race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability.
- d. Main Street School of Performing Arts will act to investigate all complaints, either formal or informal, verbal or written, of harassment or violence based on a person's race, color,

creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability, and to discipline or take appropriate action against any pupil, teacher, administrator, or other school personnel who is found to have violated this policy.

III. **DEFINITIONS**

- a. "Assault" is:
 - i. An act done with intent to cause fear in another of immediate bodily harm or death;
 - ii. The intentional infliction of or attempt to inflict bodily harm upon another; or
 - iii. The threat to do bodily harm to another with present ability to carry out the threat.

- b. "Harassment" prohibited by this policy consists of physical or verbal conduct, including, but not limited to, electronic communications, relating to an individual's or group of individuals' race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability when the conduct:
 - i. Has the purpose or effect of creating an intimidating, hostile, or offensive working or academic environment;
 - ii. Has the purpose or effect of substantially or unreasonably interfering with an individual's work or academic performance; or
 - iii. Otherwise adversely affects an individual's employment or academic opportunities.

- c. "Immediately" means as soon as possible but in no event longer than 24 hours.

- d. Protected Classifications: Definitions
 - i. "age" means the person is over the age of 25 years.

 - ii. "Disability" means any condition or characteristic that renders a person a disabled person. A disabled person is any person who:
 - 1. Has a physical, sensory, or mental impairment which materially limits one or more major life activities;
 - 2. Has a record of such an impairment; or
 - 3. Is regarded as having such an impairment.

 - iii. "Familial status" means the condition of one or more minors being domiciled with:
 - 1. Their parent or parents or the minor's legal guardian; or

2. The designee of the parent or parents or guardian with the written permission of the parent or parents or guardian. The protections afforded against harassment on the basis of family status apply to any person who is pregnant or is in the process of securing legal custody of an individual who has not attained the age of majority.
- iv. “marital status” means whether a person is single, married, remarried, divorced, separated, or a surviving spouse and, in employment cases, includes protection against harassment on the basis of the identity, situation, actions or beliefs of a spouse or former spouse.
 - v. “national origin” means the place of birth of an individual or of any of the individual’s lineal ancestors.
 - vi. “sex includes, but is not limited to, pregnancy, childbirth, and disabilities related to pregnancy or childbirth.
 - vii. “sexual orientation” means having or being perceived as having an emotional, physical, or sexual attachment to another person without regard to the sex of that person or having or being perceived as having an orientation for such attachment, or having or being perceived as having a self-image or identity not traditionally associated with one’s biological maleness or femaleness. **“Sexual orientation” does not include a physical or sexual attachment to children by an adult.**
- e. Sexual Harassment: Definition
- i. Sexual harassment consists of unwelcome sexual advances, requests for sexual favors, sexually motivated physical conduct or other verbal or physical conduct or communication of a sexual nature when:
 1. Submission to that conduct or communication is made a term or condition, either explicitly or implicitly, of obtaining employment or an education; or
 2. Submission to or rejection of that conduct or communication by an individual is used as a factor in decisions affecting that individual’s employment or education; or
 3. That conduct or communication has the purpose or effect of substantially or unreasonably interfering with an individual’s employment or education, or creating an intimidating, hostile, or offensive employment or educational environment.

- ii. Sexual harassment may include but is not limited to:
 - 1. Unwelcome verbal harassment or abuse;
 - 2. Unwelcome pressure for sexual activity;
 - 3. Unwelcome, sexually motivated, or inappropriate patting, pinching, or physical contact, other than necessary restraint of pupil(s) by teachers, administrators, or other school personnel to avoid physical harm to persons or property;
 - 4. Unwelcome sexual behavior or words, including demands for sexual favors, accompanied by implied or overt threats concerning an individual's employment or educational status;
 - 5. Unwelcome sexual behavior or words, including demands for sexual favors, accompanied by implied or overt promises of preferential treatment with regard to an individual's employment or educational status; or
 - 6. Unwelcome behavior or words directed at an individual because of gender.

iii. Sexual Violence; Definition

- 1. Sexual violence is a physical act of aggression or force or the threat thereof which involves the touching of another's intimate parts, or forcing a person to touch any person's intimate parts. Intimate parts, as defined in Minn. Stat. 609.341, includes the primary genital area, groin, inner thigh, buttocks, or breast as well as the clothing covering these areas.
- 2. Sexual violence may include, but is not limited to:
 - a. Touching, patting, grabbing, or pinching another person's intimate parts, whether that person is of the same sex or the opposite sex;
 - b. Coercing, forcing, or attempting to coerce or force the touching of anyone's intimate parts;
 - c. Coercing, forcing, or attempting to coerce or force sexual intercourse or a sexual act on another; or
 - d. Threatening to force or coerce sexual acts, including the touching of intimate parts or intercourse, on another.

iv. Violence; Definition

Violence prohibited by this policy is a physical act of aggression or assault upon another or group of individuals because of, or in a manner reasonably related to, race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability.

IV. REPORTING PROCEDURES

- a. Any person who believes he or she has been the victim of harassment or violence on the basis of race, color, creed, religion, national origin, sex, age, marital status, familial status, status with regard to public assistance, sexual orientation, or disability by a pupil, teacher, administrator, or other school personnel of the school district, or any person with knowledge or belief of conduct which may constitute harassment or violence prohibited by this policy toward a pupil, teacher, administrator, or other school personnel or group of pupils, teachers, administrators, or other school personnel must report the alleged acts immediately to the Executive Director. Main Street School of Performing Arts encourages the reporting party or complainant to use the written report form available in the front office, but oral reports shall be considered complaints as well. Nothing in this policy shall prevent any person from reporting harassment or violence directly to the Executive Director or the Executive Director's Designee.
- b. The Executive Director (or designee if the Director is unavailable) is the person responsible for receiving oral or written reports of harassment or violence prohibited by this policy. Any adult school district personnel who receive a report of harassment or violence prohibited by this policy shall inform the Executive Director or designee immediately. If the complaint involves the Executive Director, the complaint shall be made or filed directly with the School Board Chair. ***MSSPA personnel who fail to inform the Executive Director of a report of harassment or violence in a timely manner may be subject to disciplinary action.***
- c. Upon receipt of a report, the Executive Director must notify the School Board Chair immediately, without first screening or investigating the report. The Executive Director may request, but may not insist upon a written complaint. A written statement of the facts alleged will be forwarded as soon as practicable by the Executive Director to the School Board Chair. If the report was given verbally, the Executive Director shall personally reduce it to written form within 24 hours and forward it to the School Board Chair. Failure to forward any harassment or violence report or complaint as provided herein may result in disciplinary action against the Executive Director.

V. INVESTIGATION

- a. By authority of the Main Street School of Performing Arts, the School Board Chair, upon receipt of a report or complaint alleging harassment or violence prohibited by this policy, shall immediately undertake or authorize an investigation. The investigation may be conducted by school district officials or by a third party designated by MSSPA.

- b. The investigation may consist of personal interviews with the complainant, the individual(s) against whom the complaint is filed, and others who may have knowledge of the alleged incident(s) or circumstances giving rise to the complaint. The investigation may also consist of any other methods and documents deemed pertinent by the investigator.
- c. In determining whether alleged conduct constitutes a violation of this policy, Main Street School of Performing Arts should consider the surrounding circumstances, the nature of the behavior, past incidents or past or continuing patterns of behavior, the relationships between the parties involved, and the context in which the alleged incidents occurred. Whether a particular action or incident constitutes a violation of this policy requires a determination based on all the facts and surrounding circumstances.
- d. In addition, Main Street School of Performing Arts may take immediate steps, at its discretion, to protect the complainant, pupils, teachers, administrators, or other school personnel pending completion of an investigation of alleged harassment or violence prohibited by this policy.
- e. The investigation will be completed as soon as practicable. The Executive Director shall make a written report to the School Board Chair upon completion of the investigation. If the complaint involves the Executive Director, the report may be filed by the School Board Chair directly to the School Board. The report shall include a determination of whether the allegations have been substantiated as factual and whether they appear to be violations of this policy.

VI. SCHOOL DISTRICT ACTION

- a. Upon completion of the investigation, Main Street School of Performing Arts will take appropriate action. Such action may include, but is not limited to, warning, suspension, exclusion, expulsion, transfer, remediation, termination, or discharge. School district action taken for violation of this policy will be consistent with Minnesota and federal law and MSSPA policies.
- b. The result of Main Street School of Performing Arts' investigation of each complaint filed under these procedures will be reported in writing to the complainant by the school district in accordance with state and federal law regarding data or records privacy.

VII. REPRISAL

Main Street School of Performing Arts will discipline or take appropriate action against any pupil, teacher, administrator, or other school personnel who retaliates against any person who makes a good faith report of alleged harassment or violence prohibited by this policy or any person who testifies, assists, or participates in an investigation, or who testifies, assists, or participates in a proceeding or hearing relating to such harassment or violence. Retaliation includes, but is not limited to, any form of intimidation, reprisal, harassment, or intentional disparate treatment.

VIII. RIGHT TO ALTERNATIVE COMPLAINT PROCEDURES

These procedures do not deny the right of any individual to pursue other avenues of recourse which may include filing charges with the Minnesota Department of Human rights, initiating civil action, or seeking redress under state criminal statutes and/or federal law.

IX. HARASSMENT OR VIOLENCE AS ABUSE

- a. Under certain circumstances, alleged harassment or violence may also be possible abuse under Minnesota law. If so, the duties of mandatory reporting under Minn. Stat. 626.556 may be applicable.
- b. Nothing in this policy will prohibit Main Street School of Performing Arts from taking immediate action to protect victims of alleged harassment, violence, or abuse.

X. DISSEMINATION OF POLICY AND TRAINING

- a. This policy shall be conspicuously posted throughout the MSSPA school building in areas accessible to pupils and staff members.
- b. This policy shall be given to each MSSPA employee and independent contractor at the time of entering into the person's employment contract.
- c. This policy shall appear in the student handbook.
- d. Main Street School of Performing Arts will address and discuss this policy with students and employees at the beginning of each school year.
- e. Main Street School of Performing Arts implements violence prevention and character development education programs to prevent and reduce policy violations. Such programs offer instruction on character education including, but not limited to, character qualities such as attentiveness, truthfulness, respect for authority, community building, self-discipline, and resourcefulness.
- f. This policy shall be reviewed at least annually for compliance with state and federal law.
